Dog Hiking Agreement & Waiver Form

I understand that I am solely responsible for any harm caused by my dog(s) or to my dog(s) while my dog(s) is/are in the care, custody and control of Embark Dog Adventures.

I hereby give Embark Dog Adventures permission to take my dog on off-leash walks/hikes in trust that this will be done in a safe area away from traffic. I certify that, to my understanding, my dog(s) is/are trustworthy off-leash and has good recall. I realize that there are certain risks involved with off-leash walks/hikes and that I will not hold Embark Dog Adventures responsible in any way should any harm befall my dog(s).

I further understand that due to the way that dogs interact with one another, minor cuts and scratches can occur even though the dogs are carefully supervised at all times.

While my dog(s) is/are in the care and custody of Embark Dog Adventures, if I am unreachable in the event of an emergency, I hereby authorize Embark Dog Adventures, it's agents and/or representatives to seek immediate veterinary care for my dog(s). I understand that all costs in connection with veterinary, medical, or other treatment, shall be my sole responsibility.

I hereby release and agree to save and hold harmless, Embark Dog Adventures, it's directors, officers, shareholders, employees, assistants, members, and agents from any and all liability, claim, suits, actions, loss, injury, or damage of any nature or kind, or for any liability, claims, suits, actions, loss, injury, or damage which I or my dog(s) may sustain or which may be caused in any way by my dog(s). I specifically, without limitation, agree to fully indemnify Embark Dog Adventures for any and all such liability, claims, suits, actions, injury, or damage.

Relationship and Responsibilities: Between Owner and Walker

The walker undertakes to perform the agreed-on service in an attentive, reliable and caring manner and the owner undertakes to provide all necessary information to assist in this performance. The walker and Embark Dog Adventures undertakes to notify the owner of any occurrence pertaining to the dog(s) which may be relevant to the care and well-being of the dog(s). The Owner will provide suitable harnesses, collars, including proper ID tags and leads as approved by the walker as well as coats or muzzles if required.

Cancellation or Early Termination

Either party may terminate this dog walking/hiking contract a minimum of 24 (twenty-four) hours prior to the scheduled walks without incurring penalties or damages. Cancellation by the owner of the scheduled walk/hike with less than 24 (twenty-four) hours' notice/ or failure to show up for the scheduled walk/hike, will be charged \$10 to be paid before the next walk/hike. Should any dog become aggressive or dangerous, the walker may terminate this dog walking/hiking

contract with immediate effect. Any wrongful or misleading information in the owner's information sheets may constitute a breach of terms of the dog walking/hiking contract and be grounds for instant termination thereof.

Liability

Embark Dog Adventures accepts no liability for any breach of security or loss of or damage to the owner's property. If any other person has access to the property during the term of this agreement, nor are they liable for any mishap of whatsoever nature which may befall a dog caused by a dog who has unsupervised access to the outdoors. The owner shall be liable for all medical expenses and damages resulting from injury to the walker caused by the dog as well as damages to the owner's property. Embark Dog Adventures is released from any and all liability related to the transporting of dog(s) to and from any location including any walk/hike destinations, any veterinary clinic, the medical treatment of the dog(s) and the expenses thereof.

Emergencies

In the event of an emergency, Embark Dog Adventures shall contact the owner at the number(s) provided to confirm the owner's choice of action. If the owner cannot be reached in a timely manner, Embark Dog Adventures is authorized to either transport the dog(s) to the listed veterinarian, or request on-site treatment from a veterinarian or transport the dog(s) to an emergency clinic if the previous two options are not feasible.

In the rare event that a dog(s) goes missing, our policy is to round up the other dogs and wait 25 (twenty-five) minutes in the area calling for the missing dog(s). If we cannot find the dog(s) in 25 (twenty-five) minutes, we will call other staff to the area/ after 1 hour we will notify the owner as for assistance. In the event that you are out of town and you have provided us with an emergency contact, we will notify them.

Security

Embark Dog Adventures warrants to keep safe and confidential keys, remote control entry devices, access codes and personal information of the owner and to return same to the owner at the end of the contract period or immediately upon demand.

Payment

Embark Dog Adventures accepts cash or electronic transfers. We do not accept credit cards.

I certify that I have read and understand the rules and regulations set forth herein and that I have read and understand this agreement and all above information. I agree to abide by the rules and regulations and accept the terms, conditions, and statements of this agreement and confirm the truthfulness of the contracts of the application form completed by me.

Although we carefully screen all applications, occasionally we discover that this is not an appropriate environment for every dog. Embark Dog Adventures reserves the right to permanently remove a dog from walks/hikes at any time.

I will assume full responsibility for the payment, and/or reimbursement for any and all veterinary services rendered, including but not limited to diagnosis, treatment, grooming, medical supplies, and boarding. This agreement is valid from the date below and grants permission for future veterinary care without the need for additional authorization each time Embark Dog Adventures cares for one or more of my pet(s). I understand that this agreement applies to each of the pet(s) within Embark Dog Adventures' care.
